Pursuant to the recommendations made by the Inspection Committee, Compliance Report & Undertaking submitted, Compliance verification report, remittance of Affiliation & Inspection funds, NCTE recognition cited, approval of the University is hereby accorded for continuation

of Provisional Affiliation for the existing Two year B.Ed. course in Senthil College of Education, Puducherry for the academic year 2018-19 **with an intake of 100 students (Two units)** on the condition that in each subject the intake is restricted to 25 only per subject faculty.

Further Provisional Affiliation for starting new four year B.Sc.B.Ed. Integrated course **with an intake of 100 Students (Two Units)** is also granted, subject to approval of syllabus by competent bodies of the University.

The distribution of subjects as major for the B.Sc.B.Ed. course is as follows:

i) Maths (Physics & Chemistry as ancillary)	-25 + 25 = 50	} 100
ii) Physics (Maths & Chemistry as ancillary)	-25 = 25	
iii) Chemistry (Maths & Physics as ancillary)	- 25 = 25	

The approval for the above courses is accorded **subject to ratification by Academic Council and Executive Council of the University.**

The College should fulfill all the affiliation conditions as stipulated in our letter dt. 31.05.18. (Ref.7) as well as the requirements prescribed by the NCTE from time to time and as undertaken to comply with, in your Undertaking (Ref.9).

The land requirement as per University norms, not less than 5 acres should be complied with, at the earliest.

The general observations of the Inspection Committee that have been agreed to be implemented should be complied without any compromise and the final compliance shall be informed at the earliest.

All faculty positions should be filled up without existence of any vacant positions as per UGC, NCTE norms and the appointments should be made on permanent and full time basis by duly constituted Selection Committee with the University nominee.

All changes in the teaching staff and other changes that may affect the fulfillment of the conditions for affiliation should be reported to the University within a fortnight.

Request for University nominee for appointment of faculty shall be sent to the University atleast one month in advance.

The Governing Body meeting should be conducted at regular intervals as per norms with University nominee in the Governing Body and minutes submitted to the University.

University Calendar should be followed scrupulously.

Admission of students and Fee should be collected as per Govt. of India/Govt. of Puducherry/University norms.

Excess admissions beyond the sanctioned intake and admissions to courses without affiliation will not be accepted by the University.

The requirements of NCTE as enlisted in letter 2nd cited should be complied with.

The College shall strictly follow the UGC Guidelines/Regulations 2009 on curbing the menace of **ragging in Higher Educational Institutions** (Under Section 26(1)(g) of the University Grants Commission Act 1956).

The College shall constitute a **Sexual Harassment Prevention Committee** as per UGC notification dated 02.05.2016.

The Management of the institution shall discharge the statutory duties relating to pension, gratuity, provident fund, etc. for its employees.

Insurance, fire service NOC, Groundwater user license and PPA permit should be renewed periodically.

Surprise checks will be conducted to ensure that all compliances reported have been actually taken care of.

In case of violation of any of the conditions of the University, the affiliation would be withdrawn and the College alone would be responsible for all consequences in this regard. In such an event, the affiliation fund would stand forfeited to the University.

The Teaching practice and skill development of the student teachers should be undertaken only from the schools coming under the jurisdiction of Department of Education, G.O.P. with due approval of the Director, School Education, G.O.P.

This Provisional affiliation shall be valid only for a period of one academic year i.e. 2018-19. Application for starting new courses/additional intake **for the academic year 2019-20** should reach the Registrar, Pondicherry University on or before 01.10.2018 and request for renewal of continuation of Provisional Affiliation for the academic year 2019-20, in the prescribed format should reach the Registrar, Pondicherry University on or before 7th January, 2019.
