Sub: Pondicherry University – Extension of Provisional Affiliation for the B.Ed Course at Senthil College of Education, Puducherry for the academic year 2014-15 –Orders – Issued – Reg.

With reference to the above, the approval of the University is hereby accorded for extension of Provisional Affiliation for B.Ed. Course at Senthil College of Education, Puducherry for the academic year 2014-15 with an intake of 100 seats, subject to the condition that in each subject the intake is restricted to 25 only per subject faculty. This approval is further subject to appointment of qualified Lecturers as per NCTE/UGC/University norms immediately and pending ratification by Academic Council/Executive Council of the University.

The College should fulfill all the affiliation conditions as stipulated in our letter dt.09.09.14 (Ref. ii) and as well as the requirements prescribed by NCTE from time to time and as undertaken to comply with, in its Undertaking (Ref.iii).

The general observations of the Inspection Committee that have been agreed to be implemented should be complied without any compromise and the final compliance shall be informed at the earliest.

The management of the institution shall discharge the statutory duties relating to pension, gratuity, provident fund etc. for its employees.

Surprise checks will be conducted to ensure that all compliances reported have been actually taken care of.

In case of violation of any of the conditions of the University, the affiliation would be withdrawn and the College alone would be responsible for all consequences in this regard. In such an event, the affiliation fund would stand forfeited to the University.

The Teaching practice and skill development of the student teachers should be undertaken only from the schools falls under the jurisdiction of Department of Education, G.O.P. with due approval of the Director, School Education, G.O.P.

An **Affiliation Fund of Rs.50,000/-** (Rupees fifty thousand only) and **Inspection fee of Rs.25,000/-** (Rupees twenty five thousand only) shall be paid directly by means of challan in the Indian Bank, Pondicherry University Branch (A/c No.703613146) or in the form of Demand Draft drawn in favour of the Finance Officer, Pondicherry University, Puducherry.

This provisional affiliation shall be valid only for a period of one academic year i.e. 2014-15. Request for renewal for the academic year 2015-16 should reach the Registrar, Pondicherry University on or before 7th January, 2015.
